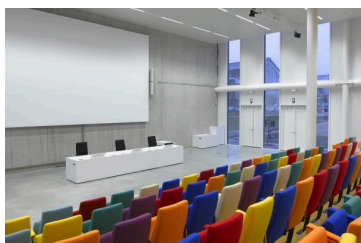

Terms and conditions

1. The effective start date of this sponsorship is the day following receipt by the organisers of this order form, duly completed and signed, and it ends at the end of the event.
2. The sponsor allows the organisers of the 'Belgian Solar Day' conference to use the sponsor's brand, logo and baseline for the communication needs of the said event.
3. The sponsor has the right to use the Belgian Solar Day conference logo on its marketing material for the duration of its sponsorship agreement.
4. The organisers of the 'Belgian Solar Day' conference event will send an invoice for the sponsorship fees within a maximum of thirty days from the date of receipt by the organisers of this order form, duly completed and signed. Payment of the sponsorship fees must be made in full within thirty days of the date of the invoice.
5. In the event of cancellation of the 'Belgian Solar Day' conference due to government restrictions or force majeure, the sponsor will have 2 options: A refund of 70% of the sponsorship fees or the automatic carry-over of the same sponsorship formula for the next edition of the 'Belgian Solar Day' conference.
6. In all other cases, the sponsorship amounts are non-refundable.
7. Notwithstanding anything to the contrary in this Agreement: (i) except in the case of willful misconduct or gross negligence, any liability of either party under this Agreement shall be limited to the amount of the total value set forth in this Agreement; and (ii) in no event shall either party be liable for any incidental, special, punitive or consequential damages, lost profits or any other indirect damages, whether in contract, tort or otherwise, even if a party has been advised of the possibility of such damages.
8. These terms and conditions shall be governed by and construed in accordance with Belgian law and the sponsor irrevocably agrees that the courts of Brussels, Belgium shall have exclusive jurisdiction to settle any dispute arising out of or in connection with these terms and conditions.
